





Q2 Which of the following have you used to learn about the Prison closing? (Choose all that apply, if any)



Q3 Do you or anyone in your household work for Chuckawalla Prison or for a business that serves the prison?





Blythe is finally able to come up for air and be in the positive. That will be ruined and completely set us back if CVSP were to close. The HUMAN FACTOR was not even considered!

Many Blythe residents employed by CVSP that want to stay are able to move to ISP (for the most part). Reducing the population of families in Blythe that are relatives of prisoners would improve the community as many are under employed, homeless, or in need of services Blythe cannot offer. They are better off elsewhere so they are able to have public services available to them for support, travel, and housing.

Our community and most businesses will experience a drastic financial impact if the prison closes. Especially businesses that provide much needed services to our community, that includes our hospital and college.

Please keep fighting to keep it open. Savechuck.org lays out convincingly why it should stay open and how it's closure would negatively impact our community.
