





We need better and protected bike routes along the road.

We need new housing

Reduce the re-zoning of rural land to high-density residential.

I'm in EDH. I'm concerned about all the development coming on hwy 50 sand hire impacted that will make EDH blvd and Folsom/bidwell, both traffic and shopping. Tx

Ensure that Tahoe receives its due share of economic development. Much of the tourist revenue is generated in Tahoe but priorities seem to focus on the western slope. To that end, it is vital that we keep political representation at the County level.

If a plant is kept in a small pot, it doesn't grow. If the County keeps it's growth artificially constrained, it will choke itself out. Make smart growth choices, not "no growth" choices.

More development on Broadway in the Grocery Outlet shopping center.

Keep shingle springs rural... don't need high density development. That was the whole reason for living here... large parcels and few neighbors.

Please don't try to turn us into a suburb of Sacramento or the Bay Area

Economic development needs to be balanced with quality of life impacts to existing residents. That includes environmental impacts, traffic, recreational opportunities, open space, and housing density.

Our infrastructure is a nightmare, poor roads full of pot holes and heavy traffic. Very poor law enforcement in El Dorado Hills, especially traffic enforcement near schools. Adding more people to this mess is the last thing we need.

The County should not continue to allow sensitive uses, such as schools, churches, and residential care homes to be built in the few commercial/industrial business parks we have (e.g. EDH Business Park, Barnett Business Park, etc) as it severely limits what other uses can locate there due to such things as noise, potential hazardous materials, etc.

Keep El Dorado County rural!

We moved to the country for a rural lifestyle. We need to ensure that our county remains rural. High development contributes to problems related to traffic and crime.

Less rentals/apartments

I don't exactly disapprove of more housing being built, but many of the projects that I have seen recently don't fit in to the area where they are being proposed, they don't adequately address traffic issues, they require re-zoning from the general plan designation, and they don't leave enough open space nor account for the visual impact of the development. My biggest objection they vastly increase density in areas away from population centers- that is simply poor planning. the density of housing matters. Rural areas should remain rural and denser housing should be planned only near denser population centers.

Green Valley congested and not many available jobs.

I believe that the county is going in a good direction by promoting growth along the service corridors, that is where road and utility services (infrastructure) exist.

We and most of our neighbors think El Dorado County is already overbuilding far too much. The recent drought we all experienced and raising the water prices ridiculously high is a perfect example. Please just stop the addition construction and let us enjoy a somewhat rural area.

Housing doesn't financially support County services in itself. Jobs/Housing balance is necessary for a sustainable economy which will financially support County services.

South Tahoe, City and County, needs MUCH more affordable housing immediately.

Tahoe is where the money is. Focus on improving the infrastructure and the \$ will follow.

Controlled, steady growth is better than no growth or too much growth

Housing development should not be simply large, expensive houses. There needs to be more affordable housing to support the need for lower to middle income workers/families. And with that, better "social hubs" for the communities between EDH and Placerville. Also, clear access to social services/supports.

Need jobs and more retail shopping

There should be no more development until it is proven that there is water available to those homes. It appears that much of our water has now been promised to Folsom to allow their development south of 50 to move forward so that puts our own development in El Dorado County in jeopardy. There is only so much water available and ElD gave much of it away to Folsom. Shame on them for not protecting their customers and their own county and for not making Folsom take responsibility for their own water issues as they had originally promised they would. Very underhanded and deceitful things going on in Folsom and with our own ElD.

I would like to see more visible evidence of effective and meaningful collaboration among the county and other government entities regarding economic development and the addressing of needed resources/services in our area.

I am in support of housing and other development as long as it is done responsibly and maintains the current look and feel of the community. More homes per acreage does not maintain the look and feel. I'm concerned that as more homes per acreage are added we

lose our rural feeling and some smaller roads (ie Malcolm Dixon, Green Valley) cannot support the additional traffic. I expect traffic on HWY 50 to increase over time. The HWY can handle additional traffic. The smaller roads is where it may create more problems.

The term "economic development" is not defined. It could mean "land and retail development that adds revenue to the County," or "development of a healthy, sustainable economic structure." A healthy structure is one where a living wage can be earned in the community where one resides. The ideal would consider sustainability a vital factor.

As the county develops, we need to maintain high standards regarding neighborhood layout (no super-dense housing like the Marble Valley proposal), traffic, quality of life (recreation, shopping, restaurants, open spaces) and even design (think EDH town center as opposed to strip malls).

fix this tahoe traffic problem before you go crazy promoting further housing growth

The County should charge fees for recreational use to non-locals.

I would love to see central Placerville (Missouri Flat area) more developed with better retail options. I live in Garden Valley and I find myself going to Folsom or Auburn to do the majority of my non-grocery shopping (or online). We can keep the surrounding area rural while providing a better retail selection. Also, there is a need for FULL TIME employment. Most of the job opportunities are part time only, and it is difficult to balance two jobs when employers will not be flexible with schedules. Current retailers, including grocery stores, only hire part time staff with inconsistent schedules. It would also be great to bring some manufacturing to the area. When the Sierra Pacific mill closed it crushed the County. I see many people who used to work at the mill, who were able to support a family, now in our Mental Health/ Drug and Alcohol programs struggling to make ends meet. Increasing job and wage opportunities will help reduce drug and alcohol dependence.

You can maintain a rural environment and still have quality of public services (such as Sheriff, Library, Animal Services, etc.). It appears that those who make the "decisions" about economic development consider the two to be mutually exclusive. The character of El Dorado County is going to change forever if the development along US 50 is allowed to continue unchecked. Letting developers destroy oak trees so they can build cookie cutter homes is not progress. You can have development if it is carefully considered and the developer actually values the character of the county. Unfortunately, that does not appear to be what is currently being allowed in the county. When I speak to others in the county about the development going on and the manner in which it is being handled they are discouraged and frustrated. I do not blame them. Something needs to change in the way the Board of Supervisors and County Planning Commission handles these matters.

Additional housing is a double-edge sword. It's needed, especially affordable housing. But what about traffic and water? Housing is basically all EDC has for taxes.

Affordable housing is needed most of all. El Dorado county should stay rural, as much as possible, and not keep approving large cookie cutter developments!

Address infrastructure first (roads, hwy 50, schools) before housing and development

We need workplace housing, not more of what we have.

I would like to see a greater number of parks for the residents of the county. Sporting greens are great, but it would be wonderful to have regular parks for residents to gather outside.

We need more bike paths.

The county continues to allow homes to be built without holding the contractor to take care of the infastructure: roads, water, highway, etc. Highway 50 is gridlocked during morning and afternoon commutes and county doesn't care. Water isn't there for these developments, and the developments don't include mello roos to compensate the county.

I live near Folsom, so can easily access retail shopping otherwise unavailable to ED county residents.

No more thrift stores. We need department stores like a Kohls . We need quality store that do not require us to drive to folsom

Please invest in the roads in South Lake Tahoe; especially after the winter months. Also, please address the Vacation Home Rental issues and provide enforcement to those that are breaking the noise issues.

Most folks moved to this area because it was considered a bedroom community with nice homes, little traffic, and good schools. More homes, more people, more traffic will diminish the attraction of this area. Currently if someone wanted to move into this county, there are plenty of available homes for sale without building more.

Reduce regulations so we can have more bldg.

1. Don't lower the TIM fees anymore. 2. Invite commercial and industrial businesses into the county 3. Build retail in our last corridors so people shop local... Cameron Park, El Dorrado Hills, Shingle Springs and Mo Flat Corridors

Need businesses that support higher incomes. The majority are service industry or retail that don't support folks buying a home, much less affording rent.

The strength of El Dorado county is rural open space and nature areas. That's why we moved to EDH (and likely everyone else). Don't spoil our only natural resource with more development! Utilize existing developments more effectively, for example Town Center could use more restaurants and entertainment options. EDH lacking paved bike trails like Folsom has - current roads are unsafe for bikes.

The County needs to live within their means and not overspend. Economic development is not the solution, budgeting and not

overspending is the solution.

While developing more housing, infrastructure must grow at the same level and time as housing. We will also need more education and medical services for that growing population.

Infrastructure is insufficient for the quantity of development and people in El Dorado County. Don't allow this environment to become any more urban rat drug development oriented please.

Better bike lanes, more law enforcement.

Slow growth unless and until highway 50 is expanded (especially given in-progress Folsom expansion which will greatly impact traffic for El Dorado County residents).

Many people live here due to the rural feel. We can't ignore their wishes but we need to create more housing for workers. Creating rental housing and other lower-income housing is important. As long as it is done in a way that balances need for economy of scale/affordability and preservation of open space, it could make EDC more attractive to people here. Without sufficient housing, everything that comes on the market will be snapped up by wealthier people from out of the area and taken out of the rental or first-time home-buyer markets, pushing our workforce out of our own county. We need to be proactive about this. Those others have every right to come here and buy things at market price. We can't start hating people for coming here. We just need to make room for them because they're going to come anyway! Build at the lower end and it will relieve that crunch. It might even prevent some people who have in insufficient income to handle rising costs from becoming homeless.

The possible responses are very disjointed. For instance you asked about economic development and listed schools as a response. Also, the county doesn't control the amount of property taxes or development fees that go to schools. Very poorly worded/structured survey in my opinion that will divulge little useful information.

Small housing tracts are OK (20-50 houses). The 600 to 10,000 units are too many to be grouped together. The apartment complex in Town Center is a very bad idea.

To clarify, I support building new worker affordable housing in South Lake Tahoe. I don't support the rampant sprawl that is happening on the Western Slope.

Build the El Dorado Trail as it is supposed to be built and see the economic benefits literally roll in.

I think affordable housing is pretty much up there on the classification of needs.....

We need an Economic Development (ED) definition such as ED ib El dorado County is about creating an environment in which business can sustain and grow, resulting in a healthy business sector, with job creation, an expansion of economic activity, increased sales and tax revenue, a healthy sense of community worth and an ever improving quality of life.

El Dorado County is environmentally fragile. Increasing development and the transportation needed to support it will bring congestion and negative environmental impacts to the region. The challenge is to show how economic development can avoid these problems.

Keep additional development low density

If building costs were not so high in el dorado county, I believe we would have more growth and tax base. At this stage it is far to expensive in permit and TIM fees for new construction.

I favor more housing development as long as lot sizes are large enough to limit density somewhat and to backfill empty land around areas already developed such as the Town Center apartment proposal and the area west of Latrobe near Blue Shield. Need transport options as

well.

Does that county even have an economic development plan?

The county is ignoring the economic potential the South Fork American river. This is one of the premier whitewater destinations in the State and Country. The county, sadly, dedicates very few resources to this excellent natural feature. I have been to meetings where the Rec. Manager has clearly communicated her disinterest in the river.

No more housing! More housing will lower our home values and bring unwanted traffic and congestion to our already impacted schools. Stop the development!

Measure Y and subsequent initiatives have made it clear that county residents expect new development to pay their full share to mitigate their impacts on the county transportation system. This limits the County Board of Supervisors ability to give incentives to new commercial development to locate in El Dorado County. This is fine with me. I don't need more services, and I don't need more shopping opportunities. That is apparently the position of the majority of EDC voters. If development wants to come here, they need to mitigate their impacts on the transportation system.

Let Sac County and points West bear the brunt of growth. Let's keep EDC a safe haven for nature and wildlife.

We are a bedroom community to the Sacramento job market. Most of those employeed in Sac shop Folsom. El Dorado hills continues to embody examples of car-centric, land intensive, residential development. For these reasons, and though I am aware of the affordable housing crisis here and elsewhere in the state, I hesitate to endorse the creation of more housing. Neither development of ranchette-style homes in rural El Dorado County (an inefficient use of land and a tax on existing infrastructure) or suburban-style single-family homes built without walkable or bikeable connection to existing jobs, commercial development or to other homes are affordable housing solutions; nor is such development aligned with general smart growth practices.

A lot of seniors are on fixed income. Inflation is a killer for them as well as minimum wage employees. Try and pass bonds that don't include people 65 and over

I wish we had more affordable housing, grocery stores, and retail stores in town. We are not Vail, CO and we do not want to be like Vail. It seems like the locals are getting pushed out of town with everything so expensive that none of us can survive.

Growth is going to happen. Let's plan for it by being smart and working together to provide affordable homes for our children to come back to (if they want) and for others who are just starting their careers. Being the "retirement" county of California (and the US) will only stifle economic development.
