

Q1 In 2005, Gig Harbor voters approved a tax levy for a \$3.5 million bond used to pay for park improvements. As housing values have increased this tax levy has gone from \$0.22 per \$1,000 in assessed valuation in 2006, down to \$0.065 per \$1,000 of assessed valuation in 2023. This tax levy expires this year.



Every \$1 million in funding is estimated to require a levy of \$0.0166 per \$1,000 of assessed property value, so an \$800,000 home would pay approximately \$13.28 annually for every \$1 million funded.



Q3 Which of these other possible city park projects would you be willing to pay for with a 20-year property tax increase, if any? (Choose all that apply)






There is a number of parks in and around Gig harbor not to mention we have \$ going to Pen Met also.

The Soundview Forest Park does not show up on the city's web page. It would be helpful to have a map showing where the community center is proposed.

Please tear down the ugly (and non-historic) Masonic Lodge and use that space for more recreation opportunities that benefit the community. The cost to restore the lodge is too much to seriously consider. The Crescent Creek Master Plan should be a priority for the council.

You have spent ENOUGH on sports. Please now give year round activities for the non sports people- senior center, arts, culture in buildings for use in any weather.

Organic gardening and facilities need to be fragrance free to eliminate pollution and safely accessible for immune compromised such as asthma, copd, chemo patients, children and pets.

Soundview Forest Park? Did you change the name? It used to be Grandview Forest Park. I think just taking a flash vote on ideas this big may lead to negative, skewed results, in the absence of prior public explanations of options. This vote is the last of a long list of public interactions and educational events that should occur first. This is a pretend democratic intervention without adequate education and dialogue. This kind of vote cold turkey is not a best practice.

Why would you put a Senior center at the center of all the traffic on Soundview and Harborview? Sorry I can't see that as being a sound idea. Plus it was bought to save Heron nest and trees or did the city forget.

Investment in our parks adds to our quality of life and is well worth the cost.

So you make it sound like the fisherman are not getting their commercial dock now?? Very frustrating

More parks, less ball fields, please.

As long as the funding prioritizes creating the donkey creek to Cushman trail connection and extending the Cushman Trail then I will support it.

Merge with PenMet parks.

If any of these projects are put to a vote, and the vote doesn't pass, would these projects still able to get funding from the city?

Please build more fields for the kids to play sports and make sure we add lighting for winter. There is an urgent need for this so kids don't have to line up late at night to use the very few fields we have and play at 8:00-9:30pm.

It's time for the city to quit investing in new or expanded parks and start investing in actually implementing a downtown parking facility and improved retail and small living spaces that bring value to the citizens. We have enough park property and those that use those properties are minimal in comparison to the overall population. If baseball, leagues, and soccer leagues, and bocce ball leagues, and even other sports facilities are expanded, that should be at the expense of those who

are participating? We have no real affordable housing for elderly people in downtown Gig Harbor. Why not two-story buildings downtown with retail shops on the bottom and affordable condominiums on top, a walkable, a small grocery store, minihardware store, artisan and citizen activities stores, community feeling, social, etc. Let's increase density and community downtown for those who have lived in the cit their whole lives. We need to rebuild of downtown, we don't need trinket shops and liquor stores.

Install EV Chargers at some of the parks

We need to make a distinction between "parks" and "playing" fields. They are not one and the same.

Have any state grants have been explored to help offset sports fields cost?

Maintain Wilkinson Park as well as you can and initiate yearly Open Houses there so citizens can appreciate what that family did to help support the Gig Harbor citizens.

We have plenty of nice parks and taxes are already too high.

We need fields!!!! Please urge the council to fulfill their commitment to the sports complex! The community is and will be behind it

The fisherman and waterfront have gotten enough funds spent on them in the past 10 years. It is time to put the money toward lighted turf fields for children and families in our community.

Please don't waste taxpayer money on the masonic lodge-there are better uses for crescent creek park to make it natural and beautiful. Look for other spots in the city for a community center. And isn't commercial fishing an industry, not a park? How does that business fit in? Is there a park component?

We need fields! Kids are losing because we don't have enough. Simple as that.

Gig Harbor is worth investing in!

Senior center and public pool should be first priorities.

Definitely against any funding for lighted fields as part of a sport complex. We do not need more fields when those at the schools are not being used. I understand that the YMCA has been unable to secure funding necessary to build the fields. That should show us that the interest lies elsewhere and that lighted fields are not a priority.

Create a program to label tree species and teach more about identifying and caring for our forests. Stop spraying so copiously along trails and do more weeding and gravel approaches.

I would want to hear more about the scope and impact of each project before making any decisions. Is there an existing need? What is the expected usage? etc.

Upgrade and maintain existing parks before creating new ones

Soundview house is not sufficient for a senior center. Too small, multi level, not enough parking. Don't even consider it.

These questions are too vague for me to make an informed decision. I need more details and more information. There are a lot of levy asks and I am a senior citizen with limited income, but not low income, and fear that I will not be able to stay in my home if property taxes keep rising. I want to support local projects but want to see what other funding sources are contributing to them other than property owners.

We have an extreme lack of park space, field space and trail space. Please take action to correct these issues. It's difficult or impossible to find green space to play soccer with my son on the weekends. Super frustrating.

Seniors and Pickleball need to be a priority. Enough with all the ball fields

Would love a Senior Center but not with any impact to Soundview Forest—let it remain untouched.

We are new to this community (second year) and really appreciate the parks, trails, and recreational infrastructure provided and supported here.

The Gig Harbor Sports Complex is LONG OVERDUE. The City can make this happen!

Lack of understanding as to why city requires additional taxes on top of already steep property tax increases. Need to explain to the public where is the money being spent before asking for more

Then we build the kayak park storage at 8 million and now have more land, parks, Fisherman's waterfront dock and more. The city can not do so many projects and you have money for many smaller ones. Don't over tax your citizens. Rebuild a simple playground at the civic center and connect the Cushman trail to downtown. Call it good and be proud.

It has become such a financial struggle for most senior citizens to support another tax increase for our town.

We need an aquatic center.
