







I don't feel these extreme measures are necessary. I wished I had voiced my concern in the restaurant where the servers were not wearing facemasks I am an at risk person and won't feel safe for a long time to come! I visited a barbershop, and the employees wore masks, and had set the shop for social distancing Doesnt matter I don't agree with the government telling businesses what to or that I have to wear a mask. Frankly the different layers of government have made it confusing. They have opened businesses that are face to face with customers but have not opened hotels where its fairly easy to follow the protocols.

I am personally not going out much still, once to Home Depot, a couple times to Ace Hardware (not all wearing masks). They are showing that touching contaminating surfaces is not the most likely way to catch COVID so I don't fear touching surfaces (and the solution is to wash your hands-simple enough). I would like to get a haircut and be able to use public restrooms in stores.

I would like more direction on expectations for customers. I also feel like there is sometimes a mixed message between focusing on they reopening of businesses and the economy, but then being told to only engage in essential activities.

Not sure who is required to wear a mask, or if its all just recommendation. I feel like those handling food should be required, but I visited a restaurant via drive thru and not a single employee within was wearing one, even though I as the customer in my car was.

I have been to several restaurants in Auburn, including Round Table Pizza, and none of them are following the Stage 2 guidelines. There is always several employees without masks and gloves, the majority of customers are not wearing masks, and customers are sitting too close together. I do not feel safe visiting any business in Placer County right now because they are doing a poor job of following the health department guidelines. If the County is going to allow them to open, then you need to enforce the rules with citations and fines.

If anything, most businesses are going way beyond what I need to feel comfortable. It has always been strange to me that grocery stores have wipes available as you walk in yet drug stores do not.

Businesses are doing much better than people. Seems like half my neighbors are already completely back to normal, with parties and travel, while the other half are completely sheltered in place still.

I would really like to see more enforcement of guidelines for businesses. Although many are doing an OK to good job, there are some which have been doing a terrible job from day 1 and don't seem to care.

Everyone needs to wear a mask to protect others. I understand why businesses aren't enforcing it for customers but I won't shop there in person if they don't.

Please instruct businesses to encourage people to follow CDC guidelines on masks, hand washing, disinfecting and distancing while doing business, but also, to limit the amount of businesses they frequent. More importantly, instruct businesses to ensure the safety of their employees, and to support time off they might need if they deem preventative distancing from the work place is needed without retaliation. I'm staying home, not shopping except for groceries until you all figure out that you're opening too fast. You are opening not because it is safe but because you have available hospital beds.

I feel we are ready for stage 3.

I don't believe masks and 6 feet distancing matters. I think you either shelter all the way or not at all. I believe the virus has run its course and that this is all unnecessary and frightening for our small kids.

I would like to see a requirement for all to wear masks.

Some people and businesses don't care and some do. Too bad we can't think about others and not just ourselves.

As i previously mentioned, I've only been to one establishment since we reopened. It was a good experience. Employees were wearing masks. The floor was marked with an "x" where people should stand in line to pay and the person at the register was disinfecting the counter and high touch surfaces after each customer. I felt comfortable and appreciated their efforts to keep the community safe. In turn, i was wearing a mask to protect them.

Went to pickup food order at the Fountains right after the Stage 2 opening. The center was relatively busy and I was the only non-employee I noticed wearing a mask. I understand it's an outdoor center, but still disappointed.

To me, the scariest poor compliance business is a bar because for obvious reasons people are less cautious in such conditions.

This absolutely should not be the new normal. I feel like this is not far off from the standard flu to the younger generation and maybe a little worse than the standard flu to the generation that is older than 65 and have underlying conditions.

There has been a steady uptick of positive tests in Placer County since we entered Stage 2. It would be great if we could shift from reopening to reimagining and give business an opportunity to innovate and thrive in the new normal.

I feel very safe going back into businesses. And it really helps my psyche and gives me hope.

The businesses are doing a good job of postings and limiting customers, but many customers are not abiding by the rules.

I would like my church to reopen.

I really don't think it wise to welcome hoards of people from other areas where the infection rate has been higher (like Sac & the Bay Area) to our area where we have had a very low infection rate.

I think as many restrictions as possible should be lifted, and people and businesses should be allowed to operate according to their own discretion. People are risk averse, responsible, and for the most part good. We don't need lots of rules and regulations to keep us safe.

What the state and county is doing with this very slow opening, is destroying our culture and livelihoods and is our country!

The key here is educating older and at risk folks about protecting themselves and having better equipment to do so (I'm 65, FWIW). We cannot afford to destroy our economy and the future of our youth's education via lock-downs. In my opinion, the energy spent trying to control all of society should be put behind us, and we should be doubling down on educating and equipping at risk groups instead, as the primary focus.

I see as I drive through Auburn that younger men and women (50ish and young) aren't wearing masks and keeping their distance. I'm over 65 and I'll do what is necessary to keep myself safe and Healthy!!

There is no direction being provided. Everyone thinks something different. Without direction this mess will simply continue

That everyone does the best they can for themselves, their family, and the community to keep everyone safe.

I went shopping and there was no stock!!!

Please just be more struck on either requiring distance and or masks of All people. It only takes one careless/rebellious person.

I think this is being drawn out too long and not healthy for anyone

I think masks by everyone should be mandatory. Strong recommendations is not working and many appear to be complacent and not wearing masks this week where they were a week or two ago. Many think the virus is over and that the virus was all a media hoax, which it is not.

Placer County should have mandatory mask requirements in grocery stores, post offices, and other busy public spaces. "Suggesting" masks isn't working. Maybe 50% are wearing masks at Safeway in Tahoe City. That needs to be 100% or it won't keep people safe.

Too many Placer Auburn / Colfax folks think none of the precautions apply to them. Nobody in any business does anything but signage about maskless customers. Less than half of Safeway/Target customers wear masks.

I apprecviate businesses that set up special hours for seniors.

Neither businesses nor customers are doing what has been asked anywhere in Roseville I've been. And yet our county Board of Supes wants to push to go further when cases are increasing? We know what is going to happen if people don't get their acts together. This virus didn't go anywhere. Everyone just got sick of being home. Their complacency is going to get someone(a) killed.

I believe we are all adults, we know about Covid and our own situations and have to take personal responsibility. If I don't feel that a business is too crowded or isn't cleaned well then I can make the decision not to shop there. I am capable the wearing a mask if I feel the need, and washing my hands, and keeping my distance. I understand the reason for the government involvement and the initial lockdown when we didn't have the information that we have now and when our Healthcare system wasn't prepared. Now I feel that the curve has been flattened and that we can make our own decisions about how to protect are family members or ourselves if we are at higher risk.

Somebody needs to be enforcing face masks.

Some business, especially restaurants and my hair salon, seem to be following what I consider basic safety by wearing face masks and maintain physical distancing...others, not so much.

I don't understand why food preparers and servers aren't wearing masks.

There is much less visible cleaning of high touch surfaces. Partitions put in place to protect employees are sometimes too short, too narrow or just too small to contain saliva or sputum. Placer County needs to increase testing and contact tracing. Sacto tells all to go to Cal Expo. I haven't heard peep from Placer County, Rocklin/Roseville about testing spots. I don't really trust being out and about even if the county only has 219 cases and 9 deaths.

It appears in my area of Placer County, Auburn, Ca, most businesses and persons are not taking the stage rules seriously.

Skip stage 2, 3 and 4 and just open the country up again. It is enough

I am surprised at how many shoppers, some old and unhealthy-looking, have stopped wearing masks, even when employees are wearing them and signs are posted.

Our cases have spiked and our county is acting like life should go back to normal. I can't believe the amount of people not wearing masks - it's rude and thoughtless and I hate having to go into any business that isn't requiring them.

Restaurant employees should wear clear face shield. Cooks and prep should wear masks

Follow the science, err on the side of precaution. Eastern Nevada County has 6 new cases, I point a finger directly at Memorial Day torism.

I think masks would prevent spread without social distancing and then some businesses could serve more people.

The curve is flattened. No one is getting sick this is ridiculous everything should open.

I'm all for not wearing a mask!

Not everyone takes masking and distancing with the same level of seriousness, so I am protecting my customers and myself as best I can and learning to be flexible. My store is my livelihood, so I don't refuse service to folks who don't wear masks, but I keep mine on!

Business indemnity for COVID infections of employees (primarily) should be predicated on adherence to published guidelines (masks, distancing, food prep, etc.) especially considering the current understanding of transmission is by exhalation in enclosed spaces (with limited/inadequate ventilation). This becomes 10x worse in the summer months as no one wants to crank up the aircon more than necessary which will adversely affect ventilation and recirculate the virus within those spaces.

Places are open, people are not wearing masks, social distancing has lessened, people are feeling comfortable and free to do as they please. I think Placer Co. has rushed to open for businesses and people's need to recreate, and are leaving people less safe with no way to actually insure our safety. I would rather have had support for business and for people people to have stayed home longer. Very disappointed in what seems like an economic rush. Understandable need on the part of businesses, but dangerous and contrary to what medical experts advise and feel comfortable with.

I just wish everyone would wear a mask....it is so easy and can help stop the spread.....so just do it!

Eg daycare risk, eating out risk, what needs someone has and what they don't. How to reduce risk, instead of having friends over, only do that during good weather outside, and BYOB

I think that staff at businesses feel intimidated/ uncomfortable to enforce guidelines that customers are clearly ignoring, because so many are doing it in this area and are actually vocal about protesting social distancing requirements. At my own business we have had some Karens be very confrontational abut not wanting to follow the guidelines we have in place (to follow County guidelines...) What a time to be alive in a red county

So far I believe that of all the businesses, including restaurants have shown remarkable flexibility and adaptation to provide a safe transaction.

Yes, stop dictating how they operate their businesses and let the customers decide. Thiss level of government interference is wrong and needs to be stopped.

People-customers-need to understand the mask is mainly for the protection of other people-including the workers of the business.

Make masks mandatory for customers and employees at all businesses

As I went to sit down on a bench adjacent to the ATM, she moved away. She was skittish of everyone and she told a gentleman walking up to the ATM next to the one she was using that she'd like for him to wait because she hasn't been out yet and was trying to maintain distance from everyone. Folks that scared should go out at a less popular time or else have someone run errands for them. I've been in several businesses where servers refill drink cups (leaning over the table and your cup, less than two feet from your face) and aren't wearing their mask (although they might have it around their neck); also, businesses with a barrier, which they lean around get closer to the customer. Many of the businesses don't seem to take the requirements seriously, although some definitely do.

Local businesses truly seem to be making great efforts to keep employees and customers safe. What I've noticed is some inconsiderate customers ignoring those safeguards.
