



Survey Results: Little Cottonwood Canyon Traffic





Q4 The Utah Department of Transportation (UDOT) has been evaluating different ways to reduce passenger vehicle trips up Little Cottonwood Canyon by 30%. They recently said that a gondola to Snowbird and Alta, with a base station at La Caille, is their preferred alternative. This proposed solution would also include increased and improved bus service (with no canyon roadway widening), tolling or restrictions on single occupancy vehicles, and the construction of a mobility hub. The entire project would cost an estimated \$550 million (in 2020 dollars).

no single capacity unless you live in the canyon or work at a resort. we also need to focus on people who enjoy many parts of the canyon. what about hiking? a gondola would go right over all this. More buses from te Trax station and the mouth of LCC are needed. Making things easy for people is what we need.

Why are we looking to solve the problem for the ski areas? They should be solving it for us. The governance of this whole gondola issue was dubious from the get-go with McCandless as the head of CWC - we all got hoodwinked.

I think more park and ride options or requiring busing for all but employees would be another solution that could assist. It would require more parking and more buses at the base of the canyon. Also need options for entire year and multiple drop points as well.

No tax money for these things. Resorts should handle their own parking issues.

Seems obvious to try tolling the road first before excessively spending taxpayer dollars to service 2 private businesses.

Electric busses, with more frequent busses and better load/unload sites. Double the number of busses during peak hours and have them dedicated to one resort or the other to encourage more ridership. (I've heard a lot of people complain that going

to both resorts takes too much time. During peak hours, it seems busses would fill up to both resorts.)

I've worked at Snowbird for 40 years, this problem only exists on powder days and on weekends with powder. Throughout the rest of the week, and year, I can drive to Snowbird in less than 15 minutes. The only reason this is an issue is because of the property owners greed, and cronyism at its best. By far the best option is avalanche town, and several wide sections made only four buses that can bypass traffic. This is such a debacle I cannot believe we are still debating it, and I suspect that if the gondola moves forward that would be so many lawsuits that it will never be completed.

I am not in favor of a gondola unless it is entirely funded by private entities. It is not a good use of tax payer dollars.

I don't go up in the winter, but I think they need to look at something closer to the management of Zion Canyon than a gondola.

Better bus service

This is a seasonal issue. More busses, reservation parking, and monitoring of cars entering the base of the canyon to ensure they have a reservation in private cars would streamline the cars that go up the canyon. Even a silly gondola is going to cause traffic and parking issues at the base of the canyon and quite honestly could increase traffic congestion all the more.

Investigate the current traffic(citizens using the canyon now) more closely with surveys to get best info for what is really happening this winter and continue to brainstorm solutions (big and small) for all aspects that will make it better NOW and in the future.

The goal should be to attract skiers and snowboarders to Utah with easy access to the canyons and keeping the costs of winter sports as low as possible. Disneyland offers discounts to local and state residents. Perhaps the ski resorts need to look at this also.

1. Drivers turning east from south bound Wasatch Blvd onto 9400 S are a significant reason Wasatch Blvd backs up so far to the south. It is aggressive drivers that try to jump the line by turning at the LaCaille sign. The gondola does not move enough passengers per hour to solve the problem, rather than a 2 hour line to drive up the canyon I will have to wait for 2 hours to get on an expensive gondola that takes 45 minutes to get to the resort that is 15 minutes away by bus.

Pretty sure they've all been though of, except possibly electric trolleys in a continuous loop.

Stop letting folks wait for the canyon to open. Intersections are blocked and if emergency devices had to come they couldn't get here. Frequent Bussing and extremely limited car service would be better not gondola

I thought this was a UDOT decision and we're still 1 year plus from any from decision being funded? Why is Sandy spending so much time on this? Waste of resources.

The popular climbing areas such as White Pine, Lisa Falls, Pipeline, Tanners Gulch, etc. need stops and services from any transportation hub.

The elephant in the room is the number of empty seats in cars that go up and down the canyon. If that unused resource could be used for more people the problem would go away. The simplest solution is to implement a ridesharing app that connects drivers and passengers going up and down. To incentivise the transition you could add fees for unused seats.

We are strongly against building a gondola. It is not making any logical sense to spent 500mil + of taxpayers money. It is scam.

Stop messing around and get serious about the train that connects to Trax and goes all the way to Park City.

More buses during peak travel. Let those who benefit most from this pay for it... not the taxpayers! The overpriced Resorts.

Snowbird should pay for more busses since the IKON pass is mainly responsible for the traffic issues. They're more interested in their profits than the traffic!

More buses are needed.

head tax on everyone who goes up to ski

Sandy City Mayor needs to get onboard with the gondola solution and please stop all the negative campaigning against it.

Keep polling! That build credibility and transparency in our leaders! Thank you for doing this and empowering the community to take action and become part of the solution!

Put up cones to get people to use the full length of the merge lanes. People often merge as quick as they can and block the merge lanes (one car in two lanes) and completely defeat the purpose of this system. Have cops at the two major intersections (le Caille Light and (9400S and Wasatch) to control merges. Actually, enforce the traction laws for once!!! Write tickets to those that don't follow them. The sticker system helps!! Traffic only moves as fast as the slowest vehicles and a couple of cars are regularly causing the majority of the issues.

The fact that the gondola only stops at the ski resorts and not any of the trailheads is telling. If it comes to be, it should be privately funded.

Those that use it should pay for it. OR the resorts that want the traffic can pay for it.

Little Cottonwood Traffic issues are seasonal. It comes with having beautiful mountains and ski resorts.

Thank you for considering solutions to this issue.

UDOT wants to force me to pay for specialized transport to two private ski resorts, it's insulting. Why isn't anyone talking about limiting sales of passes and ski resort access? If the national parks can have timed entries why can't the resorts? So many of us use the canyons outside of ski season and take advantage of non-resort winter activities. The gondola will only serve those who pay to ski and completely disenfranchise the local community.

Why is Big Cottonwood Canyon being ignored? Why are the resorts not building more parking?

The Gondola is the BEST option for reducing emissions and congestion!!!

Electric Bus is a better solution than the gondola - more parking more busses - better storage at the resorts for boots/snowboard/skis etc at a reasonable price not \$500 for the winter when a pass is over 1k per adult -

I prefer an EV busing solution that would seem to be effective in both winter and summer. Gondola seems mostly winter-only due to limited stops (at the resorts). And EV busing should be the norm for both Cottonwood canyons. I am not sure why we would subsidize something so expensive that benefits just the ski resorts.

Resorts may need to have a lottery for admission on high ski days to make it fair for all.

Look at other recreational areas and national parks that have year round shuttles. Consider how well it works un other places.

Buses and other ride share options provide maximum flexibility - they can be constantly adjusted to hone in timing and funding options; locking us into a permanent solution like a gondola is not a very wise approach, considering we have no idea how climate change will ultimately impact these ski resorts and the rest of the canyon.

I don't think the tax payers show fund projects that ski resorts could afford and will improve there profits even if they charged people to ride

They should build snow sheds over major avalanche paths.

Enforce carpooling. Express bus lanes.

More buses or lanes doesn't actually provide an alternative solution - it's more of the same. Gondola provides an actual alternative and provides choice between bus, private vehicle, and gondola.

Obviously Big Cottonwood Canyon has the bigger traffic issue. Little Cottonwood has been picked for this because the former Utah Legislative Senator owns the property where the gondola will start and he will make a ton of money!

I only go sking every few years. Thus, this is rally not a problem for me. Other than I can not go up the Canyon to enjoy any other beauty during the Winter. I think they need a reservation system for the resorts and then only allow them up the canyon to sky if they have reservations. That way they could control the numbers. A bus system would be just fine. You could pay drivers a big raise with \$550 million dollars.

Stop the gondola. Too expensive, bad for environment, slow, only needed a few days a year (peak times), would be running empty for 98% of year. Government funded with no funds from resorts makes no sense, only good for 2% or less of Utahans.

Any costs should be shared with the ski resorts. The Utah taxpayers shouldn't have to bear the burden of making transportation changes that private companies benefit from. Also, the ski resorts shouldn't be able to purchase the property that the gondola parking lot will be placed on.

I think the reservations were working. I think that it is important to consider all sides. We should move slowly when it comes to changing the mountainsides with gondolas! Yuck!

Locals have had to absorb ALL the pain — increased ridiculous traffic AND ridiculous increased lift tickets. STOP ADVERTISING!

Ride sharing insentive program

I think reservations at the resorts until full and then close the canyon would help mitigate the problem with a gate that can close near the last parking area (Wasatch Blvd/S.R. 209/9400 S. for turn around reasons) I'm very concerned about a gondola particularly if there are mechanical issues and it breaks down with people suspended that far above the canyon. In addition to that, it would destroy the beauty of the canyon.

I use the canyon back country. None of the solutions proposed would help parking or transport to those locations

The reduction of the bus schedule has had a major negative effect on the canyons traffic - both canyons. Multiple times I have tried to take the ski bus but the buses are full or the lines at the bus stops are so long it is an unacceptable wait.

The resorts have to pay for the Gondola if it is passed. It benefits them and I do not ski!

I strongly oppose the gondola. There are several cheaper, simpler, and more eco-friendly solutions.

I am concerned about two things. First I think that the ski resorts should be paying for transportation that mainly benefits the resorts rather than expect city, state, or federal tax payers to pay for it. Second, I think that whatever is done should benefit

people who use the canyon outside of the resorts, particularly those who use the white pine trailhead for accessing the mountains in winter.

The residents do not want the gondola, please listen to the people who use the canyon all year round and live in the area of the gondola.

Gondola seems like a very short-sided idea to address the issue. It might make a small impact but I don't see regular usage from citizens utilizing the gondola.

The ski industry has created this nightmare by raising the cost of a day ticket and forcing people to buy a season pass in addition to the multi-area passes which bring skiers from great distances to UT. Now they want premium charges on powder days to solve the daily cashflow loss because they aren't selling day tickets!

This is very important. It is hard to get my kids to school because of the traffic on Wasatch.

We need to figure out if global warming will make gondola a wasted expense in 20 years.

Do the simple solutions that address the few days/times that it is actually a problem. The alternatives they are proposing are so costly.

Good luck solving a problem that only exists for a limited number of days per year.

Paid parking reservations, no parking on the roads. If you don't have a spot you don't go. Also, paid park reservations should be time dependent to streamline traffic up the canyons. Accountability on behalf of the resorts to whom this problem is driven by needs to be taken up, not everyday Utah citizens that may not even ski or snowboard.

I do not want to subsidize ski resorts. I would allow them to issue bonds to pay for their gondola. Tax payers already support the ski resorts in many other ways. Airport, buses, roads, etc.

The merchants in the community benefit from the skier population. The resorts should expedite avalance control and provide more parking and finance additional transportation that brings their cllents. We locals are only inconvenienced on powder days and know how to circumvent the lines. Se do not want to mar the canyon views with gondola towers!

I sometimes think the gondola is being forced down our throats. For a handfull of days during the ski season, it seems the expenditure for a gondola is excessive and should not be bourne by the taxpayer whether federal or local. It only benefits the ski resorts. Were there a tunnel to Park City, at least the mines could be drained, secondary water could be brought to the valley and transportation would have essentially no impact on the environment. Granted, it would cost more, but with the additional long-term benefits and potential revenues, why not consider it?

Stop trying to sabotage the buses to justify the gondola! Building it would destroy many of the other amazing recreation areas in the canyon -- not to mention the beauty of the canyon itself. We have existing infrastructure in place to solve the problem if UTA starts paying drivers a living wage & the 4WD/chains rules are actually enforced.

Get rid of the Icon pass. That would probably reduce the number of people coming to ski.

Niederhouser follies need to be reported and ended!!!!!!!!!!

Increasing bus frequency and promoting the use of buses would be the greatest solution in my opinion.

Put a toll booth in. Start with dynamic pricing based on how many occupants and how crowded the canyon is. Charge people from out of state double.

A solution for a day trip just to visit the place and enjoy the mountains without having to ski or to pay to get there would be great.

Parking structures should be built in Alta and more structures at Snowbird. Let these private businesses pay for their own improvements. Government should not be paying for private business interests that only benefit a small number of people.

Mandate 4x4 or AWD with Winter Tires Not Mud and Snow. Mud and Snow tires become much harder when temperature drops to 40 degrees Fahrenheit or below; they provide little to no traction on ice or snow packed roads. The science is clear on this matter. Make it a class B misdemeanor to be in the canyon without above at any time Nov1-Apr 30.

To spend half a billion dollars to solve a problem on just 60 days in the year is ridiculous. With paid parking/parking reservations and a poor snow year, 21/22 had very few traffic jams. 22/23 has much more snow so more road closures. All less invasive/less costly measures need to be implemented for several years before even widening the road is considered. Work with UTA to improve bus service (it was 40 minutes late this morning), absolutely enforce the traction law better, and toll during peak hours. Those need no physical infrastructure change, no additional pavement, yet will certainly manage traffic much better. The gondola and road widening don't take in to account the tragic fact that skiing in the Wasatch will be declining as the lake dries up and the world continues to warm. Definitely against toll roads

I wish people would understand the reality of the gondola increasing lines and even more congestion at the mouth of the canyon. It isn't realistic to think people wouldnt need to park at the base station. There would still be congestion!! It would

isn't realistic to think skiers could stand in line for the gondola, fully clothed for skiing and then ride the gondola for 30+ minutes. That is not a good option, and such a favor to the prior legislator that purchased the LaCaille property.

I am not sure why the citizens need to bear the burden to shuttle tourists to the ski resorts. If the resorts want a gondola, the resorts should raise the \$500MM. Given climate change, will there even be a skiable snow season in our future? If we build the gondola and the industry dries up, it would be a complete waste of money.

More bus service. Dedicated uphill lane to bus in morning and dedicated bus lane at end of day.

As Utah ski resorts have grown interest, they are making more money. Provide shuttles and set expectations. Limit passes, setup staggered time slots for skiers. Not an and intrusive gondola that would only be used by skiers going to the resorts. The mess and the noise alone is not worth the cost.

No gondola

I am not keen on scarring the views/landscape of the mountainside. While I realize that something needs to be addressed, I also know that the LOCAL people would not support, through RIDERSHIP, the idea of a gondola. Even in the summer, all of our canyons are becoming un drivable because of the traffic and BICYCLISTS! They scream about the cars, but I want to scream about how unsafe I feel trying to keep them safe on narrow roads with one steep side.

Somehow providing a way that traffic (if it is still there) can be queued up in a lane while still allowing local traffic to move around. There are back ways that we know about to take our kids to Granite Elementary, but for those that live in that triangular area near Wasatch/LCC Rd, and down LCC Rd, the traffic can greatly impede normal access to the neighborhoods.

The ski resort skiing area has limitations in terms of people. I do not favor spending the funds for a solution that is only open half the uear and benefits only the resorts. I think traffic incentives and bus options are better.

NO GONDOLA!

Tolling, electronic tolling at the mouth of the canyons; pricing/encouragement for carpooling. Electric buses; extra bus lane likely NOT needed; gondola is a bad idea - doesn't really solve much, and would created other/additional traffic problems around the Base Station.

Consider tiered toll pricing based on the number of passengers. This would incentivize single passenger cars to pick up additional passengers.

Defining the possible "improvements" at the 94th and Highland is important. Building a multistory structure and describing the increase in bus traffic is important in understanding the impacts on that intersection.

Buses are fabulous. I am angry that they reduced bus service. Crowded busses make it hard to ride with kids when seating is limited and I have to wrangle all their equipment. I frequently use the Big Cottonwood busses to ski when I ski alone, but when I take the kids, I drive. Better busses with adequate seating, meaning more frequent busses, please!!!!

more premium parking for cars with 3-4 passengers.

Let the people/corporations making the money from skiing pay for the solution that is benefiting them.

From the perspective of someone who skis at resorts in these Canyons on a regular basis, it seems that parking reservations during busy times has helped LCC the most. However, that canyon backs up on busy mornings when the road is closed due to avalanche control. If a gondola could still run while the road is closed for avy control, this might help. Otherwise, Mother Nature pretty much has control due to the nature of this canyon. I certainly think parking reservations at both resorts (as opposed to just paid reservations at Solitude) would help in Big Cottonwood Canyon.

The solution needs to be a 12 month of the year solution, and an all activities solution (not just ski resorts). Frequent buses (likely with restrictions on private vehicles) is the best option to keep the canyons accessible to everyone.

Agondola is NOT the solution under any circumstances!

I don't use the canyon in the winter as I don't ski. It is the summer traffic that concerns me. Don't think the gondola is Amy good because you can't stop at the trail heads. The huge parking lot would be awful.

NO GONDOLA

This is another one of those issues being forced upon us by outside interested. My solution would be to limit the number of ski passes sold for each day, and then have a check station at the bottom of the canyon. If you do not have a ski pass for that

day, you don't get up the canyon. The rest of the year, (not durning ski season) the canyons would be open.

I think a reservation system at the ski resorts is key; especially on weekends and holidays

Limit vehicles that can go up. Resorts need to have a cap and utilize a reservation system to limit the load up the road and in the canyon.

I think increased busses would help

It not a Sandy issue

More frequent buses. UTA cut ski bus service in half this year and it's ridiculous. It was already hard to get a bus down the canyon at the end of a ski day. It wasn't uncommon to wait an hour at snowbird for a bus with space going down. Why would they cut ski bus service? It doesn't make sense. Also UTA should be free

Work with UTA to restore the bus schedule to every 15min, if not greater. Have the resorts fund a traction law checkpoint at the base of each canyon with a turn around route constructed to allow non compliant vehicles to exit the canyon without causing congestion.

I am opposed to the gondola. It will only benefit the resorts. All other options should be pursued, especially increased busing, increased carpooling, and a reservation system for parking at the resorts. I have lived in Sandy most of my life and frequently go to Little Cottonwood Canyon. The gondola will be a blight on the landscape forever and will only marginally solve the traffic problem which is only a problem 10-12 days a year. Sandy government officials should do everything they can to oppose the gondola.

No gondola in LCC.

I am concerned about how access to parts of the canyon other than the ski resorts would be affected.

Ski resorts need to front money to add buses, solutions.

Convince Snowbird and Alta to become boutique ski areas that only accept pass holders to those resorts and drops the ikon pass.

I am STRONGLY opposed to the gondola. I have not seen ANY evidence they it would be good at all.

Put the cost on the resorts and the skiers, not the taxpayers. And do not widen Wasatch Blvd

It should not be up to the taxpayers to subsidize people accessing the ski resort. Decreasing the numbers going up the canyon can be accomplished by the ski resorts working out their own transportation issues, increasing their prices, and doing everything by reservation.

Big Cottonwood is just as bad, this too needs to be rectified. I know that it is not a Sandy City problem.

The gondola s a foolish idea in that you can exit only at the resorts. The problem is that people don't always want to go to the resorts. Another problem is that, as we all know, the \$500 million gondola will cost more than a billion dollars just as the new state prison did.

Gondola and road widening are not options. Improve buses or other car-pooling type transit that doesn't penalize the people that are using the canyon for non ski resort activities.

No gondola, regardless of where the funds originate. I certainly don't want a cent of my tax dollars to go towards it. I'd rather see the ski resorts suffer economically than destroy the pristine nature of Little Cottonwood.

No one wants the gondola. 90% of the SLC metro area is against it. People want more buses and or enforcement of traction law. Make people have snow tires and 4wd or chains.

Bus brigade on weekends and holidays. The buses load at available parking lots and leave at the same times, to get skiers there at the start times for the ticket they purchased. Traffic is stopped and the buses go up in a brigade. Reverse the process at the end of half day and full day tickets.

Buses will not solve the problem. Widening the road is the wrong way to solve the problem. The gondola solves the problem with the least impact on the environment. The decision is not Sandy City's decision. Why do we keep getting these surveys?

I think busing is the best solution.

The number of single occupant vehicles is staggering. A toll based on occupancy should be applied. 1 occupant = 30 2 occupant = 20 3 occupant = 10 4 or more = free Allow single occupants to take the bus for free.

Ski resorts are the sole beneficiary of all suggested solutions. They should dig into their massive profits and seriously contribute to the solution. Don't burden the Utah taxpayers with the costs.

I do not think that the gondola is appropriate for the location. I think it's horrific financial abuse to fund it by taxpayers when it is only for the benefit of two specific ski resorts and their patrons. Busses are the correct answer, and a bus lane, if possible.

UDOT needs to work directly with Sandy Mayor Zoltanski. Mayor Z has many great ideas to help resolve the traffic issue if the committee, UDOT and the State will work with her directly. The State and UDOT are in excluding the city that will be impacted directly for the gondola. When I was reading all the gondola comments there were very FEW in support of the gondola. The proposal also was very narrowminded in its position and didn't truly present the NO in those comments. I personally know of no one in support of the gondola (people from many locations in the valley).

Maintain the Sandy police escorts; increase frequency of bus systems; and continue to look for short-term incremental improvements right now as there is no current funding to do anything.

It is clear that the Gondola idea will only ease traffic congestion for less than a few weeks each year. Further, private companies are asking the Utah taxpayers to foot the bill. Let *them* pay to get their customers up to the resorts. The gondola should be stopped at all costs.

I don't think a gondola is a good solution. People go up the canyon for other reasons than just to get to the ski resort. The construction will have a big environmental impact. Other solutions should be put in place- not the gondola.

Parking garages at the resort's main parking lots.

We live here for a reason locals should have some benefits. We go up the canyon more in the summer so we are against the gondola and tolling.

The state needs to allow development of the mountains on the west side of the valley so that people can go there and ski and hike. I'd rather the money be spent that way.

I don't think it's fair to ask taxpayers to fund a gondola that would solely benefit ski resorts

I think more options for people to get up the canyon are great. Really don't want a gondola- so many expenses to maintain it. More parking for carpools and more buses would be great. Not everyone in our community can afford fees to drive up eitherjust the gas for the drive up the canyon is felt in their budgets and all families should have access.

Charge a toll, for all vehicles. Put a cap on the total amount of vehicles which can go up the canyon each day. Do not allow vehicles with a single person, this will encourage the use of a carpool system and use of existing park and ride lots

Increased electric buses are the best way to handle the situation. Tolling, with cost reductions the more passengers in the vehicles, is an additional alternative (in addition to buses).

Let the resorts supply bus services. Don't count on UTA

Build the gondola!

I think it was wrong for Sandy (and other political entities) to come out against the alternatives for the canyons even before they reviewed them (some were even before it was announced!!). It was arrogant and not what I expect of my community leaders---it was a knee-jerk reaction to get attention, but not at all helpful in the process. Many alternatives have to be explored, and the ultimate solution may be a combination of several ideas to address this very complex issue. To try and take ideas off the table because of an uniformed political stunt is unacceptable to me as a Sandy constituent.

Carpools of 4+ should not pay the toll if there was one. There should be more buses, and two new park and rides at Hidden Valley Park and Wasatch Blvd. and Wasatch Blvd and Highland Drive.

Your survey comment boxes are too character limited! The concept of a non-road-based transit system is good, combined w/on road transit options. What is proposed as the preferred option (Gondola) is overkill. Can we have some MTB trails in the canyon? I realize outside scope. By placing a gondola txn hub at the base - UDOT is moving the traffic problem further down the road, will still be a traffic jam accessing the garages. That said - one Camry w/o snow tires or w/inexperienced driver can shut the entire road with effects lingering for hours. Huge impacts on environment/revenue - etc. All the gondola nay-sayers forget this as they want to preserve the current status quo. This is short sighted and does not consider big picture. there has to be some option between 750 MIL and doing nothing. Oh - and the UDOT road improvement option? (opposed to the Gondola option) No place to park once you drive up the improved road! and STILL - ONE car can shu the place down or bring it to a sto

The gondola is a solution for 10-12 days of heavy traffic during the year. Are we really to think everyone will just start using it all year even when I won't drop off hikers at any point other than a resort? Catering to private resorts is not a creative use of taxpayer money just for those 10 days of traffic. Since it will most likely not pay for itself I believe it to be a future liability for taxpayers and would result in a major transfer from public coffers into real estate developers and private resorts. Other infrastructure projects especially around water seem more important than ease of access to a resort for 10 days of the year. In essense the gondola is a narrow solution to a larger regional transportation issue facing all the canyons not just the isolated case of LCC and we are refusing to consider. So I think a more flexible, varied strategy for the time being as we come together to solve it. As stewards of this iconic beauty we can do much better.

Add a permanent 3rd lane on Little & Big Cottonwood Canyon Drives and use it as a traffic density lane. Two lanes going East in the mornings. Two lanes going West in the afternoon/evenings.

70% of respondents to the previous full survey indicating NO GONDOLA should be sufficient to shut down this conversation on a Gondola.

I don't ski so I really don't care about the traffic. However I don't think taxpayers should be saddled with this problem especially with the \$500M price tag of the gondola. That project is nothing more than bragging rights. What should happen is the ski resorts should pay to shuttle people up the canyon via UTA busses.

More shuttle buses for people to use to each ski resorts. I am totally against putting a gondola.

(2) A gondola would ruin the natural beauty of the canyon. Plus, spending over \$550 million of taxpayers money for a gondola is beyond prudence or reason, particularly for a "ski season" concern. Our taxpayer monies should be spent on more important issues, or returned to the taxpayer. (3) The DOT and City Counsel should work with the Town of Alta, Wasatch Backcountry Alliance and the Forest Service to further explore replacing the parking spaces being used by non-ski area visitors (Alta states it is over 200 spaces) & continue with open parking. Access to hiking trails should be free. Do not add costs to that traffic, just resort traffic.

The skiers should be the ones flipping the bill

Initiate tolling & support for car-pooling ASAP!!!

No to the Gondola. Make a toll to go up during peak times to fund some free buses that go up

Lift discounts for people who ride share, use public transportation or carpool.

Build the gondola! Stop private cars driving up the canyon please

Have a reservation system for the ski resorts where people have to make a reservation per vehicle before going up and only give resorts a limited amount of reservations, and have a limited amount of reservations for those just wanting to go for a ride.

When I drive in Sandy I am "stuck" at 100 more places that the Canyon.

Skiers that are not residenst should be required to pay higher fees for any type of transportation to the ski slopes if Utah taxpayers end up funding the gondola

No gondola.

Parking reservations work and have been easy to book as an Alta skier. Snowbird should implement reservations as well. I do think the fee should be reduced to \$5-\$10 max or incentivized by number of people in vehicle. We also need more buses with adequate seating. The deterrent is having to stand with all of you ski stuff.

Improve park and ride lots down at the base of the canyon. Encourage carpooling websites.

I don't ski so don't go up the canyon in the winter. However, any reduction of traffic using mass transit methods anywhere in the state has my vote. As an aside, I have traveled to other countries who have gondolas for much the same purpose. During the spring, summer, & fall the gondolas attracted tourists for scenic tours. I would love a gondola ride during the fall color myself. Great idea, please keep pursuing it.

If transportation only serves private interests, it should be paid for by private sources. It's ridiculous to expect taxpayers to pay for a gondola that only benefits private ski resorts.

There is high risk of avalanches and rock slides endangering ground transportation, which may demand snow sheds. Other popular recreation sites, including Tony Grove, exist in Little Cottonwood Canyon and need access. Safe wildlife highway crossings need address, especially when widening highway.

Ski resorts charge WAY too much anyway, today, you have to be rich to ski. I'm middle class, and it's WAY TOO MUCH to use OUR beautiful mountains. There should ALWAYS be ONE FREE ski run open for ALL UTAH RESIDENTS, Resorts shouldn't be able to charge such astronomical prices. There should be 1 free run at each resort. With a limit of 2 or 3 trips. OR there should be a CAP on SKI ticket prices! And RESORTS should just send free SHUTTLES to EXTRA stops. And for those who take the shuttle should be rewarded to take them by saving a significant amount on ski tickets. And season passes. I NEVER take buses because I don't trust bus drivers driving skills in the canyon.

I am strongly opposed to gondola since there are many other options instead.

Ticket people that pull in front of incoming traffic at stop lights and then can't move forward to get out of the way

Why aren't we talking about priority bus lanes or simply removing the option of driving a private vehicle during peak times? Yes, this is inconvenient. But it will be the most effective solution.

NO GONDOLA, improved base parking lots, more frequent buses, resort shuttles to Sandy, increased ride share opportunities

Whatever the solution is, the bill should be paid by those who financially benefit from it. The struggling tax payers shouldn't have to pay to get people up to the resorts. It should be those who stand to benefit from it that should pay. If people own property/cabins in the canyons then they should pay. If you want tax payers to fund this, tax those who own businesses/properties in the canyon. I don't think the public camp grounds are causing the traffic jams in the winter since they are used mostly in the summer months. There doesn't seem to be a traffic jam problem in the summer so I wouldn't use federal/state tax funds for the winter traffic jams.
