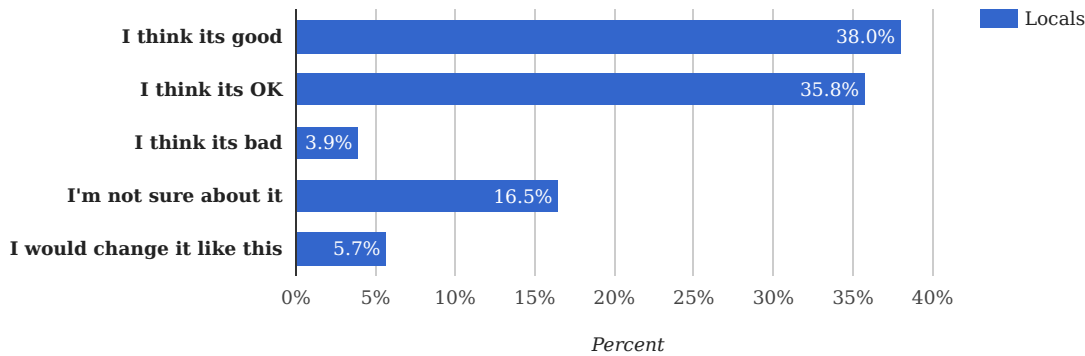

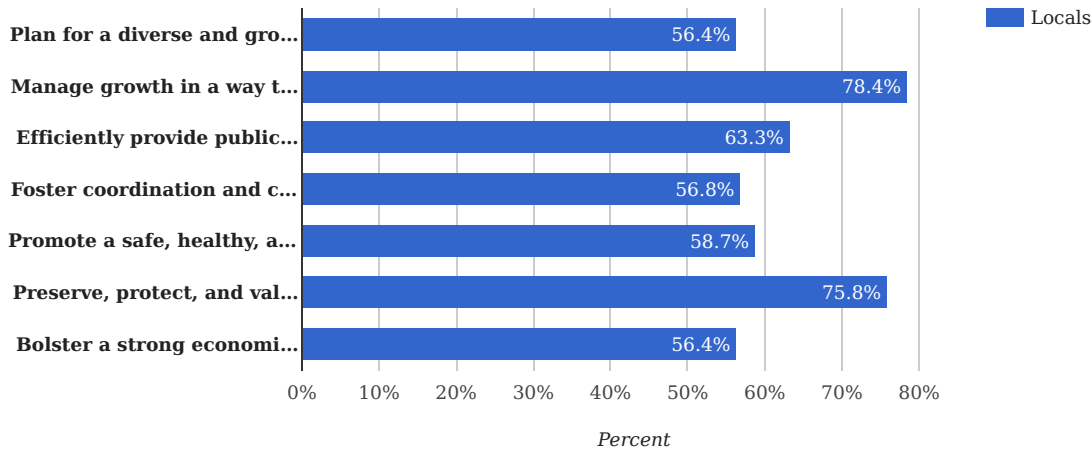
Unfiltered responses

- It's bland, too non-specific, can mean anything and everything to anyone and everyone. I've got nothing better though.

Developing land is not all that is important - we do not have the natural resources to continue to destroy the region with cement and empty housing & not enough roads, water & public services.

A regional approach to planning and problem solving.

If those questions were intentionally worded to support EDawn and its operations, I want you to know - I do not support EDawn. I believe the EPIC report is a bunch of crap.

Doing a pretty good job so far. Wait and see as we begin to grow more

I think you should have asked us to prioritize the previous items.

Revitalize neglected areas hand in hand with promoting new developments.

How about quit building houses in places such as Spanish Springs. We were told 20 years ago when our house was built that the land currently being built on would not be touched. Not only are we dealing with traffic problems it seems we fo not have a water supply to support this unwanted growth.

I might add to maintain our unique or distinct qualities to your opening statement.

Much of the content provided in this survey made vague and in-actionable goals, which are hard for me to get excited about. I recommend being much more specific about the goals to help keep projects focused. For example, instead of things like "maximize use of resources", say "build roadways that are designed to support a 50% growth rate over the next 10 years while maintaining average traffic times of no more than 25 minutes for a 15 mile drive". We have specific problems we need to address, not vague problems. Our goals and mission statements need to be specific in order to address those specific problems. Thanks for the chance at input!

Where is the water going to come from to support all the new developments???

As we continue to grow we must have the schools built in a timely manner not after they are overcrowded!

Limit growth to the bounds of existing infrastructure and resources. Insure that development pays the price of infrastructure expansion, and brings in the resources to support the growth. Revise existing laws that prohibit passing infrastructure on to developers.

I believe our infrastructure is already being overwhelmed by the rapid pace of growth in the Truckee Meadows. We need to negotiate a better deal with developers in order to maintain schools and build new ones. The new developments should be built with an eye to water conservation (as should all homes). In order to reduce congestion and wear and tear on our roadways, public transport should be easily accessible - much more so than it is.

Increase the inventory of single family residences. Continue to develop the mid-town to downtown corridor while involving the ever growing university which should feed right back into our local economy with each class of graduates. Prepare and develop accordingly for the influx of residents from both Northern California and those working at TRIC. Promote local business over national and international chains. Continue to promote and organize local events that highlight our four seasons and beautiful surroundings while engaging citizens new and long-established. THANK YOU!

Do not allow growth if the resources are not available. In addition, restrict growth if the 10 year (or maybe 5 year) average resource availability is above 80% utilized (possibly 90%) for the year. Keep our community sustainable without fear of droughts.

We should be building a community that is economically resilient and fiscally sustainable but that also values the conservation of our natural resources and western heritage.

We must consolidate the several governmental agencies. We have had three of everything for this valley for too long. Far too much effort and money is spent by our several local governments protecting each of their respective fiefdoms instead of maximizing the tax dollar in a reasonable way.

Reno is growing very rapidly. In future, as new communities develop, we must maintain a sense and awareness of how this development impacts our current communities, while ensuring their long term prosperity and integration into a growing society. These communities must be brought into the present, through Utility updating, Safety maintenance, and whatever is needed to maintain these neighborhoods and keeping the residents safe and prosperous.

Water conservation should be considered in every proposal for our community.

Manage the rate of growth to ensure it does not outpace availability of resources or jeopardize the natural environment.

Make it unique. If you substitute TM with any other community in the statement. You wouldn't know the difference. This is a boiler plate corporate vision statement. Please put some effort into it.

Plan around the water available in dry years. No water no development. Don't get cute with how you measure the amount of water. Be realistic.

Growth is not always the solution. Growth increases pollution, strains scarce resources such as water and increases overall congestion. A large portion of the people living in this area do so because it is not California! If you want California, move there.

My vision is not for the City of Reno to control every community in the Truckee Meadows. I however am for ways the communities in the Truckee Meadows can work together to save money on mutually beneficial services.

I checked all the statements but want to emphasize growth within the constraints of our natural resources and the size of our valley. I would not like to have to move because of lack of water or excessive pollution.

It is not government's role to induce or support "diversity". It is government's role to protect the rights of life, liberty, and property of citizens that are already here and have contributed to the society and enjoy the benefits they paid for... nothing more.

Focus on drugs and crime in downtown Reno. Fix the blight that is Virginia St downtown with closed businesses.

Housing contracts need to support new schools roads parks in newly formed neighborhoods. Affordable housing interspersed with medium and high end neighborhoods. Environmental issues satisfied with concern for people animals flora and fauna of the area. Hiking and biking paths or spaces incorporated into newly formed neighborhoods

What are the proposals to accomplish the goals?

I don't know the plan, so I can't give you really intelligent answers, but I would certainly say that those of us who pay property taxes shouldn't have to look at the fences in extreme disrepair along the backs of homes on major thoroughfares like McCarran and Kietzke. NDOT needs to start a plan to make the area from 4th going east and then south to Prater and Kietzke between Vasser and Plumb, less visually disturbing. It looks great where the panels have been added but our neighborhood has been neglected and looks like a slum, though we pay taxes on two homes.

Draft statement isn't future-focused on what the region wants to be. It's focused on the status quo, including the vision condition statements. Need to ask young adults what they want the region to become. It's a vision of the future, not a politically non-offensive statement.

make it more family and kid friendly, also address and remedy the homeless population. get the gang/graffiti under control as much as possible.

Statements that encourage/plan for alternative transportation are attractive. Also, those that encourage local business growth, aside from casinos and adult entertainment industry..

I am afraid that we have opened a 'Pandora's Box' by allowing mega employers such as Tesla and the ensuing support industries into the region. The resulting vast number of job openings far outstrip the available workforce we currently have. Now the race is on to expand the population base/workforce far faster and in greater numbers than the region can comfortably handle or sustain.

I think we really need to look at making good use on the land available in town first, before focusing on creating more urban sprawl. There are so many properties that can be rejuvenated in town, where there is already services and infrastructure to support them. So much of the focus now seems to be sprawling farther out of town. If you are looking at lower income housing, it should be built closer to services, not out of town.

With the growth of the downtown area I would like to see plans for driving population density and new industry (tech, financial, etc.) to that area. Less urban sprawl and higher population density downtown will allow the area to function more like other cities with issues like public transit. I am a big fan of the changes that have been going on in that area and would like to see how policy, funds and legislation is continuing to drive that momentum.

The vision is always much better than the implementation which seems to depend upon the political wind. I don't feel optimistic about the future of the community.

Plan the infrastructure before approving big projects. Squaw Valley is going to be a disaster!

We have the unique opportunity to show not only Nevada, but the United States healthy, historical, ecological developmental growth that can be uniquely ours. Do not erase or forget our history, our open spaces, our needs for healthy opportunities for all ages in all our communities. Not just Reno and the south end of Truckee Meadows!

Make sure that we have adequate roads to handle the large amount of traffic that is already here and we only grow in the future.

Start with utilizing current structures to house local businesses. Invest in basal job skills as early as middle School but focus on high school, enforce current laws especially in WC parks.

Do not let the population growth over power the water supply at it's lowest level. Synchronize the traffic lights throughout the region to reduce vehicle idling for long periods. Yes this can be accomplished with a coordinated effort from all agencies. If we can send a man to the moon we can fix the traffic flow.

Mc Carren blvd. and Pyramid should have both been redone to resemble modern 6 or 8 lane freeways not congested messes with traffic lights ever 1/8 of a mile. Did anyone ever thing about a bridge over the Truckee at Pyramid before they approved 20000 homes to be built or how about alternative ways to the new jobs out in the USA Parkway. Nice Job Not!!

Spanish springs needs a freeway. Desperately. Sparks Blvd should be turned into a freeway, in conjunction with the southeast connector, that services Spanish springs directly to the I-80 and damonte ranch area. It should become contiguous with pyramid highway at their current junction and continue out as far as the site of the leviton factory. This is 20 years past due as it is. State funding should be more properly allocated toward northern Nevada instead of Las Vegas getting the vast majority of it.

Work with local businesses and the community as a whole. We need to ensure that we are not out pacing growth, income, and cost of living. Cost of living is already higher than what most people make in this area and it is not something that is going to see this community grow.

Build more schools!

Roads and infrastructure must be updated and maintained For this to work. Must keep on top of this and budget for it!
